Rules of a Personal sports fund

In order for a Personal Sports Fund to reclaim gift aid and remain charitable, you must adhere to the following rules;

The donor paying into a particular PSF must not be a beneficiary of that PSF, neither should the spouse, husband or civil partner of the donor, nor a relative of the donor (brother, sister, ancestor or descendant) or the wife, husband or civil partner of a relative, or a company under the control of the donor or a person connected with the donor

The payment of money into a fund must not come with a condition of repayment.

Applications for support costs to be paid by the WSF from a particular PSF can only be made on the presentation of certain valid invoices relating to the following:

- Equipment, Coaching & competition Entrance fees
- Air fare or other travel invoice
- Accommodation cost in a training resort or area and we will pay out for the stay of one parent or guardian to accompany an athlete under the age of 18 years old
- Insurance costs
- Travel costs from the athlete's home to a training venue when submitted with the invoice for the training costs at that venue paid at 26 pence per mile as stated on the HMRC web site.

95% of the donation and of any associated gift aid received will be applied to the PSF nominated by the donor to the WSF

I understand the rules of the Personal Sports Funds and agree to the Winter Sports Foundation periodically checking the worthiness of claims. Excessive or inflated claims are a criminal offence and can be reported to HMRC. I understand that I have relied on my own tax and legal advice and / or my own judgment in opening a personal sports fund and that the Winter Sports Foundation have openly disclaimed any liability to any parties entering into the arrangement.
